### **Appointments**

- CAP appointed Jeanine Dudle to serve as the CAP representative to the Undergraduate Outcomes Assessment Committee (UOAC) in academic year 2019-2020
- CAP appointed Jill Rulfs to serve as the CAP representative to the Educational Development Council (EDC) for the spring term in academic year 2019-2020
- CAP appointed Raghvendra Cowlagi (AE) to serve as the CAP representative to the Committee on Information Technology and Policy (CITP) in academic year 2019-2020

# Motions Brought to the WPI Faculty for VOTE

- Motion to modify policy allowing Commencement participation for undergraduates who have not yet completed their requirements (February 13<sup>th</sup> 2020)
- Motion to allow students to be paid for credit-bearing work on sponsored projects (March 23<sup>rd</sup> 2020)
- Joint COG & CAP motion to provide students with the option to receive Pass/NR grades for undergraduate courses during D-term 2020 (March 27<sup>th</sup> 2020)
- Joint CGSR & CAP motion to adjust course evaluation reporting for D-term and Spring 2020 (April 16 2020)
- Joint COG & CAP motion to provide students with the option to receive Pass/NR grades for undergraduate students whose PQP/IQP/MQP or HUA Practicum/Inquiry Seminar were affected by the pandemic during D-term 2020 (May 7<sup>th</sup> 2020)
- Joint COG & CAP motion to provide students with the option to receive Pass/NR grades for undergraduate courses during Summer term 2020 (May 21st 2020)

## **Additional Committee Activity**

CAP worked with Library Services on the e-projects 2.0 site for digital publication. We worked
with WPI's general counsel and Corporate Engagement on the WPI Master Student Sponsored
Project Agreement, which provides a template for all IQP and MQP sponsored activity

- At the January 16 2020 faculty meeting, CAP presented on the Online Course Reporting System (OSCAR)
- After WPI essentially closed its campus in D term because of the novel coronavirus, CAP engaged with COG and CGSR frequently to ensure a consistent message to faculty, undergraduate and graduate students
- CAP endorsed a request from registrar (for D term only) to allow students to overload up to 21.75 credits without requiring advisor approval (while strongly encouraging students to seek approval of their advisor)
- While crafting the Pass/NR grading motion, CAP extended discussions with Mass Academy administration (Michael Barney) as well as leaders of the Reserve Officer Training Corps (ROTC), LTC Jack Skiles for Air Force ROTC and LTC Adam Heppe for Army ROTC

### **Additional Committee Activity**

- CAP recommended that the Office of Undergraduate Studies should become more involved with the operation of MQP sites as the need arises
- Chair Heineman with other chairs of standing faculty governance committees signed a letter to the administration "Faculty Statement in Opposition to PCRIAP" (Process for Creating and Revising Institutional Administrative Policies) dated April 16 2020

- Review of WPI's academic programs; assess what constitutes an "active" WPI program
