The 'A' Award is a four-year grant designed for the early independent career scientist who wants to establish a career in pediatric oncology research. The ideal applicant has an original project that is not currently being funded. Demonstration of a future commitment to pediatric cancer investigation, as well as institutional support for the career development of the investigator, are critical components of a successful application. A career development plan should be outlined; inclusion of a mentoring plan for at least the first 1-2 years of support is strongly encouraged.

### ➤ Alex's Lemonade Stand Foundation (ALSF) for Childhood Cancer: Psychosocial Grants

- **Deadline: June 15, 2020 for LOI**
- **Grant Range: up to \$100K to \$300K over 2 to 3 years**

ALSF offers two different Psychosocial Grant opportunities:

**Launch Grants** are designed for early career researchers within 7 years of receiving their terminal degree/completing formal training. Funding will support studies that aim to explain and/or improve psychosocial outcomes of those affected by childhood cancer. Demonstration of outstanding mentorship and a career plan that shows commitment to pediatric cancer investigation are important components of a successful application. Maximum \$50,000 per year for two years will be awarded to applicants.

**Family Impact Grants** are designed for established investigators. Funding will support studies that aim to explain and/or improve psychosocial outcomes of those affected by childhood cancer. These grants are designed to fund researchers who have novel approaches to understanding the psychosocial aspects of pediatric cancer and whose proposals will have clinically significant impact. Award amount is a maximum of \$100,000 per year for three years.

### ➤ Alfred P. Sloan Foundation: Chemistry of Indoor Environments

The goal of the program is to grow a new field of scientific inquiry focused on understanding the fundamental chemistry taking place in indoor environments and how that chemistry is shaped by building attributes and human occupancy. The program makes grants to achieve a series of interrelated goals:

- Generate new knowledge by directly supporting original, high-quality research to identify indoor chemical sources, characterize the chemical and physical transformations taking place indoors, and determine how indoor chemistry is shaped by building attributes and occupancy.
- Develop a modeling consortium to improve the cohesiveness of the community and its ability to integrate findings.
- Build a thriving, multidisciplinary research community of chemists; environmental, civil, and mechanical engineers; architects; atmospheric scientists; microbiologists; and environmental health experts that will endure beyond the program's timeline.
- Train the next generation of scholars and practitioners. An important component of this program is introducing new voices into the field and training the next generation of researchers.
- Develop community-wide research protocols, and norms.
- Advance capacity for discovery through development of new tools for data collection, sampling, analysis, and visualization.

This AOTF/ Michael J. Fox Foundation (MJFF) grant will be available to an occupational therapist researcher serving as the principal investigator for development of preliminary evidence as well as provide pilot data for subsequent larger research projects. The goal of the study is to grow the data in need and strengthen the evidence for OT in Parkinson's Disease by asking clinically relevant questions that advance the delivery of OT. This Intervention Research Grant (IRG) is targeted to principal investigators who do not currently have substantial extramural research awards as an independent principal investigator. Typically, the principal investigator (PI) will have a funding history associated with early stage, emerging, or early midcareer investigators that may include small research grants and training-related or mentored career awards. The PI must also have a commitment from an experienced research mentor who has an established record of substantial extramural grant funding, peer-reviewed publications, and supervision and mentoring of researchers.

The foundation seeks research that builds stronger theory and empirical evidence in these two areas. The foundation intends for the research we support to inform change. While the foundation does not expect that any one study will create that change, the research should contribute to a body of useful knowledge to improve the lives of young people.

**Applicants must be nominated by their institutions. Major divisions (e.g., College of Arts and Sciences, Medical School) of an institution may nominate only one applicant each year. Contact your Department Head and WPI Foundation & Corporate Philanthropy at least one month prior to the application deadline.**

The William T. Grant Scholars Program supports career development for promising early-career researchers who are within seven years of receiving their terminal degree. The program funds five-year research and mentoring plans that significantly expand junior researchers' expertise in new disciplines, methods, and content areas. The foundation recognizes that early-career researchers are rarely given incentives or support to take such risks, so this award includes a mentoring component, as well as an emphasis on community and collaboration.

Scholars Program applicants should have a track record of conducting high-quality research and an interest in pursuing a significant shift in their trajectories as researchers. Proposed research plans must address questions of policy and practice that are relevant to the foundation's focus areas:

- programs, policies, and practices that reduce inequality in youth outcomes, and
- strategies to improve the use of research evidence in ways that benefit youth.
