Professor D. Medich called the meeting to order at 3:00 pm (US Eastern Time).

1. The minutes of the Feb. 23, 2023 (meeting \#7, AY '22/'23) were reviewed and approved.
2. The committee continued the review of Professor Van Dessel (CEAE) and Professor C. Eggleston (CEAE)'s proposal concerning a "Masters of Architecture" graduate program. The discussion topics included (a) the immediate and future needs for new courses, (b) NAAB (The National Architectural Accrediting Board)'s accreditation rules, and (c) the anticipated demand. Professors Van Dessel and Eggleston explained the NAAB accreditation process as well as their
plans to support the program with the already existing offerings and the newly proposed courses. They also highlighted the global construction industry's increasing demand for the kind of professionals that will come out of the proposed program. In addition, they noted that the amended proposal adopts a 'focus area' approach (instead of a 'concentration area' approach) as it offers more flexibility.
