This is a summary of the annual report of the WORCESTER POLYTECHNIC INSTITUTE EMPLOYEE BENEFITS PLAN, EIN 04-2121659, Plan No. 507, for period 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

WORCESTER POLYTECHNIC INSTITUTE has committed itself to pay certain self-insured Medical, and Dental claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with METROPOLITAN PROPERTY AND CASUALTY INSURANCE CO., VISION SERVICE PLAN, UNUM LIFE INSURANCE COMPANY OF AMERICA, PRUDENTIAL INSURANCE COMPANY OF AMERICA, NEW DIRECTIONS BEHAVIORAL HEALTH, and METROPOLITAN GENERAL INSURANCE COMPANY to pay Vision, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Long Term Care, and Legal claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$1,236,426.
