- 2) The Committee considered two motions from Mathematical Sciences clarifying the intended audiences of courses in Probability:
  - a) A motion to change the course description for MA 2621, Probability for Applications, was approved.
  - b) A motion to change the course description for MA 2631, Probability Theory, was approved.
- 3) The Committee considered two motions from Biomedical Engineering related to courses in Cellular Engineering:
  - a) A motion to change the name of BME 3813 to "Cellular Engineering: Techniques" was conditionally approved, subject to implementation dates.
  - b) A motion to add BME 4813, Cellular Engineering: Applications, was conditionally approved, subject to implementation dates.

#### **Old Business**

- 1. A motion (originally submitted in AY 22-23) to change the Category for ES 3501 was tabled, pending on clarification for the planned schedule for offering the course.
- 2. The Committee considered several motions regarding the restructuring of the Biology and Biotechnology curriculum (first presented in Meeting #3 on Sept. 21).

- b. A parallel motion to add BB 3060, Animal Behavior, was approved.
- c. A motion to remove BB 2950, Molecular Biology, was approved.
- d. A parallel motion to add BB 3950, Molecular Biology, was approved.
- e. A motion to remove BB 3050, Cancer Biology, was approved.
- f. A parallel motion to add BB 4050, Cancer Biology, was approved.
- g. A motion to change the name of BB 4900 to "Advanced Topics in Biology and Biotechnology" and to change the course description was conditionally approved, pending minor rewording.
