Each year, to support the faculty policy on academic honesty, the Dean of Students Office tabulates data for reported cases of academic dishonesty. On the following pages, you will find data on academic dishonesty at WPI for the 2018-2019 academic year, as well as aggregate data on academic dishonesty cases over the past five years. Additional historical data is included on the breakdown of academic dishonesty cases by type. The staff within the Dean of Students Office hopes that you find this data helpful in examining departmental trends over time.

Also attached is the revised copy of the *Faculty Guide to Academic Integrity at WPI*. This brochure has been developed to educate and remind faculty about the academic honesty policy, and to explain WPI's procedure for adjudicating academic dishonesty cases. The guide provides information on how to minimize academic dishonesty in the classroom; as noted in past years, one of the most important suggestions from students is to **clearly explain your expectations during the first day of classes, and frequently thereafter, and include concrete examples that do and do-not constitute cheating, plagiarism, facilitation, and fabrication in your course(s).**

It is important to note that a similar brochure for students (*Student Guide to Academic Integrity*) has been distributed to all undergraduate and graduate students.

## A REVIEW OF ACADEMIC DISHONESTY CASES FOR 2018-2019

Academic dishonesty continued to be the most frequent type of violation of WPI's Code of Conduct in 2018-2019 for cases adjudicated through the Dean of Students Office. In 2018-2019, there were 91 **suspected cases** initially reported to the Dean of Students Office. (*Table 1*)

Of the 92 cases reported to the Dean of Students Office in the past year, 54 were resolved by faculty at the departmental level, as the students admitted responsibility for the violation and accepted the proposed academic penalty. 29 cases were dismissed by faculty upon further investigation and discussion with the students at the departmental level. There are 2 unresolved cases.

The Campus Hearing Board (CHB) or Administrative Hearing Officer (for non-matriculated students) heard 7 cases of alleged academic dishonesty, of which all 7 were found "Responsible". None of these cases were appealed. (*Table 2*)

Educational and prevention sessions are held annually with members of the campus community – specifically, Mass Academy students, new international students (undergraduate and graduate), new graduate students and new faculty.

**Cases by Department**

Many academic departments followed up on suspected academic dishonesty cases, led by Mathematics (19) followed by Humanities and Arts (13). (**Table 3**)

## Historical Trends

### **Sanctions Imposed**

WPI faculty have the discretion to sanction students who accept responsibility for violating the Academic Honesty Policy to a penalty not to exceed an NR/F for the course. The CHB may sanction a student to a penalty of up to and including suspension or expulsion from WPI. The CHB can only make recommendations to the faculty member regarding any academic penalty for the student.

*Note: Some students received multiple sanctions for the same incident, thus the total number of sanctions exceeds the total number of incidents.*
